

## **Privacy Policy**

We are committed to protecting your privacy and helping you have a safe online experience. This Privacy Policy applies to the Park Hills Civic Association ("Park Hills Civic Association")( [www.phcahub.org](http://www.phcahub.org) & [www.phcahub.com](http://www.phcahub.com)) website and governs data collection and usage. By using our website, you consent to the data practices described in this Privacy Policy, and the terms and conditions of use, as posted on this website.

### **What Information Do We Collect?**

Park Hills Civic Association does not collect any unique information about you (such as your name, email address, etc.) except when you specifically and knowingly provide such information.

If you send us email, we may collect and store such information. We use the information to reply to your email communication. If you register as a Park Hills Civic Association Member using our online system, we may ask you for your email address collect and store this information. We use this information to process your application. Park Hills Civic Association procedures do not allow a minor to sign a membership application.

We may also use the information we collect to occasionally notify you about important functionality changes to the Web site, new Civic Association events and other City Wide events we think you'll find valuable. If you would rather not receive this information, you may opt out by sending an email to [editor@phcahub.org](mailto:editor@phcahub.org) requesting to be removed from our email blast list.

### **Information Collected Automatically**

We automatically collect information about your visit to our site. This information is used to make your visit to our site more efficient, and to help us follow browsing preferences on our site so that we can make regular improvements. Our external web host may also automatically log your IP address, a unique identifier for your computer or other access device.

### **Links to Other Sites**

This website contains links to other sites that are not owned or controlled by us. Please be aware that we are not responsible for the privacy practices of such other sites. The stories/sites displayed and/or linked to by the Park Hills Civic Association website are developed by people over whom Park Hills Civic Association exercises no control. Other links are also on sites not controlled by Park Hills Civic Association. These other sites may send their own cookies to users, collect data, or solicit personal information. Park Hills Civic Association may choose to exhibit its results in the form of a "URL redirecter." When Park Hills Civic Association uses a URL redirecter, if you click on a URL on a Park Hills Civic Association page, information about the click is sent to Park Hills Civic Association, and Park Hills Civic Association in turn sends you to the site you clicked on. Park Hills Civic Association uses this URL information to understand and improve the quality of Park Hills Civic Association's technology.

### **Disclosure of User Information**

We will disclose information about our website users if required to do so by law or in the good faith belief that such action is necessary to act under exigent circumstances to protect the personal safety of users of Park Hills Civic Association, or the public.

## **Use of Cookies**

We use “cookies” to help personalize your online experience. A cookie is a small text file that is stored on a user’s computer for record-keeping purposes. We may link the information we store in cookies to your personal information in order to provide a faster and more pleasant online experience.

We use both session ID cookies and persistent cookies. We use session cookies to make it easier for you to navigate our site. A session ID cookie expires when you close your browser. A persistent cookie remains on your hard drive for an extended period of time. You can remove persistent cookies by following directions provided in your Internet browser’s “help” file.

We set a session cookie to store your passwords, so you don’t have to enter it more than once per session. Persistent cookies enable us to track and target the interests of our users to enhance the experience on our site. You have the ability to accept or reject cookies. Most web browsers automatically accept them, but you can usually modify your browser settings to reject cookies, if you prefer. If you reject cookies, you may still use our site, but your ability to use some areas of our website will be limited.

This Privacy Policy covers the use of cookies by this website only and does not cover the use of cookies by any advertisers or third party sites that may be linked to from this site.

## **Security of your Personal Information**

The security of your personal information is important to us.

We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. No method of transmission over the Internet, or method of electronic storage, is 100% secure, however.
